Gender Equity Plan – as a recipient of funding under the Active Industry Fund from the Queensland Government, and to continue to be eligible for this funding, moving forward, PCQ is required to develop a Gender Equity Plan with an ongoing commitment to maintain it once it has been achieved. Whilst this plan will not come into effect till 2029, it is expected that the Association will begin steps to address this requirement. The Executive at its June meeting resolved to support gender equality at state level (Executive Committee) and will take positive action and affirmative steps to address gender equality through deliberation and set criteria to meet the requirements by 2029.

PCQ AGM – is scheduled for Thursday 8th September. Margie Davidson has been appointed as the Returning Officer. For further information refer to the Office Manager's report.

PCA:

2023 Fees – PCA has advised the fees as at 1st January 2023 for riding members will be \$27.50 (incl GST). This is an increase of \$11 (incl GST). PCA will respond to any questions directly from its riding members about the fee increase.

National Integrity Framework - Pony Club Australia (PCA) has committed to the implementation of the National Integrity Framework which provides greater transparency and independence for sport integrity issues. This will see major integrity concerns in Pony Club® managed by Sport Integrity Australia (SIA). Sport Integrity Australia will provide an independent and professional complaint handling service for breaches of the major policies that threaten safety and fairness. That includes things such as Abuse, Bullying, Harassment, Child Safety, Competition Manipulation and Illicit Drugs.

The new policies are on the PCA website but the standards within are very much like our past Member Protection and Child Safeguarding policies. Members report directly to SIA, and PCA (or a state, zone or club) will not be involved in the investigation or have a say on sanctions imposed for a breach of a policy.

The President asked the PCQ MPIO Melda McBeath to address the meeting. The meeting was advised that certain types of complaint were to go to PCA and Sports Integrity Australia. She had also spoken to the PCA CEO querying whether the MPIO's were still going to be viable to which she was advised yes. Depending on the type of complaint as to where it is submitted, and these complaints may also be referred back to the state, club etc. The PCQ MPIO also added that the zones and clubs will need to be made more aware of what their responsibility is, what is the breach outline etc and there will be an onus on zones and club to read the policies. The best solution is always to try and resolve at the grass roots level.

The President thanked the PCQ MPIO and resolved that PCQ will work with Melda to draft a simplistic document for circulation to zones and clubs and took the opportunity to acknowledge the wonderful work that Melda does which was endorsed by the Treasurer.

Prince Phillip Mounted Games – to be held in NSW in October 2022. As PCQ received an invitation to nominate a junior and senior team an eNews was sent to all members seeking expressions of interest. PCQ has responded back to the hosting body and are awaiting further details.

Interpacific Exchange 8-26 January 2023 – PCQ sent an eNews to members seeking expressions of interest from those riders between the age of 17-25 as at 1st January 2023 and with a "B" certificate. Nomination forms sent to those riders who meet the criteria as well as nominations for Coach and Manager, with nominations to be submitted to PCA by 26th July 2022.

National Rules Committees - PCQ sought confirmation from PCA as to whether all these committees are still relevant and functioning as it appears there has been a reduction in some of these committees meeting. The Executive also enquired in the long term, if National Discipline Rules are generated, are these rules specifically for national events or are they to be adopted Australia wide?

PCA advised the Tetrathlon, Quiz and Mounted Games committees are still active and that as the Dressage, Showjumping and Eventing committees had not met for some time there has been little progress and not sure if these committees will be re-activated.

JustGo Database:

Processing new memberships

There are multi members sitting in clubs under No Membership, there is no need to do anything with the ones that show Expired however the ones that have greyed out dots have been approved but not advised membership can now be purchased.

Migration of Data from OSM

In every member profile there is a Credentials Tile which is where Coaching, Officials, Proficiency Certificates and Horse Registrations can be found.

Unfortunately, a lot of information on the OSM database did not migrate across to JustGo and we have now lost that history. Please contact the PCQ Office if you have concerns about missing accreditations, certificates, horses etc so that we can try to rectify the problem.

Coaching & Official Accreditations

The JustGo database does not allow anything to be deleted at a state level so if any Credentials show up as Expired, they cannot be removed or updated. To overcome the problem a new Credential is created, we try to keep the original start dates but an email is sent out from PCA each time which indicates members have brand new accreditations.

Further advice to also lobby the local councillor's main office staff, to develop a strategic development plan i.e., highlighting a 5-year plan and what you are working towards.

NSW State SJ Championships – the Office Manager advised the QLD representatives enjoyed themselves and had a great time and did quite well with the only downside being a lot of theft.

Funding – the President informed the meeting of the availability of funding for zones & regions and to lobby their local RDC.

The SCI advised the meeting that new allocations would be released soon and that the acquittal process was becoming more difficult and at the end of the 6-month period, PCQ has 10 days to submit its acquittal.

Congratulations to those members who attended the State Dressage, Combined Training and Horse Trials Championships in Maryborough in July, who competed in the spirit of sportsmanship and achieving personal best performances.

Riders are well underway with preparation for the up and coming State Formal Gymkhana, Sporting Gymkhana, Stockman's Challenge, Campdraft and Mounted Games at Kilcoy in September.

Funding

Pony Club Queensland has been awarded funding from the State Government under the Active Industry Fund Program for the delivery of various programs for physical activity participation and capability improvement.

PCQ has available various funding opportunities for Zones to access. This funding can be sourced to assist in the conducting of state events, coaching programs/schools/clinics and other activities.

The updated guide for 2022-23 provides a simple explanation of what funding is available, funding value, who can apply, the application process and acquittal requirements.

As a result of funding and acquittal requirements, PCQ has streamlined the system by paying funding upfront on the completion of an agreements to utilise the funding appropriately and provide an acquittal in a timely manner after the activity and within the funding period.

Funding is available for the 1July 2022 to 30June 2023 period and must be acquitted within the funding period. Contact your Regional Director of Coaching for any assistance.


