### PCQ:

#### **Minimum Medical Standards:**

EQ has entered into an agreement with St John's Ambulance to provide services, training and products. Prior to making any decision to follow suit, PCQ will be circulating a questionnaire to clubs/zones to establish what current services are available and what providers if any, clubs and zones are using.

The President emphasised the importance of replying to questionnaire once circulated.

### **Serious Incident Management Plan:**

This has now been circulated to zones for onforwarding to clubs and can also be downloaded from the PCQ website see below link:

Query as to whether the plan is specific to horse trials. The meeting was advised no, it relates to all disciplines, the header on the document to be amended to reflect this.

### Strategic Plan:

A plan has been drafted (see attached) for the period of 2023-2025 which aligns with PCA's plan and also our requirements under our funding agreement with the Department of Tourism, Innovation and Sport. An operational plan will be formulated from this plan.

### **Emerging Athlete Pathways (EAP) Program:**

This pathway aims to foster the development of young athletes and support elite athlete pathways by providing financial assistance to help alleviate the costs associated with attending championship events. Officials (such as coaches, referees and scorers) officiating at eligible events can also apply for assistance if they meet the eligibility criteria. A PCQ eNews was circulated to all members on 7<sup>th</sup> August providing a link to the website for the eligibility criteria.

### Questionnaire:

PCQ participated in a questionnaire through QSport and delivered by the Active Queenslanders Industry Alliance (AQIA) on "What is Required to Make Sport Contemporary and Sustainable". A follow up interview was also conducted to review our response. We have been advised, once the responses have been received from all those sports that participated, a state-wide report card at the completion of the project will be provided.

A review is occurring in September with an opportunity to submit comments for review and inclusion of new gear rules for 2023. A PCQ eNews was circulated to members on the 14<sup>th</sup> August asking for feedback on the forms provided and to submitted to PCQ by the 28<sup>th</sup> August. ### 2022.09.16 General Business:

**Age of Rider** – the meeting discussed whether the age of the rider for competition will be as at 1<sup>st</sup> January as there seems to be some confusion surrounding this.

The President advised this had been discussed at the subcommittee meetings with all except one subcommittee in favour of the change and that it is hoped moving forward there will be a general consensus amongst the sub-committees to enable all to start 2023 with common ground. The Chairman of the Sporting Sub-committee addressed the meeting confirming it was this committee which was not in favour of any changes as there are particular age groups at state events. He further advised the sub-committee had checked with every zone who were all against the change.

The meeting was advised that with EA, it applies the age the rider is turning that year e.g., a rider turning 11 in May will ride as 11-year-old all year. The meeting agreed, as a decision needs to made soon it will be looked at again next meeting. It was also recognised there may be no choice if it becomes a PCA directive.

The President thanked the delegates for their comments and always welcomed their opinions.

**Minimum Medical Standards** – query as to whether an ambulance is required for a showjump competition with 55 riders. The meeting was advised, an ambulance not required however will need to contact both local ambulance and vet to advise of activity. Apparently, there is a common contact number/email address for the QAS where clubs can submit the date of the activity. Clubs can also apply for an exemption.

**IQ/PCQ Showjumping Event** – query as to whether PCQ will sending a reminder to those riders who have been invited to nominate.

The meeting was advised the dates are still to be confirmed as there is a conflict with the selected date, once this has been resolved a save the date claimer and reminders will be forwarded.

**Life Membership** – as the PCQ Vice President Tracey Camilleri was in attendance at this meeting, the President took the opportunity to again announce the bestowing of Life Membership to Tracey and repeated her words from the AGM acknowledging Tracey's contribution to pony club®.

Tracey thanked the meeting for this recognition and felt humbled and very proud of her association with pony club.

### State Championships

Riders are well underway with preparation for the up and coming State Formal Gymkhana, Sporting Gymkhana, Stockman's Challenge, Campdraft and Mounted Games at Kilcoy in September.

### **Funding**

Pony Club Queensland funding from the State Government under the Active Industry Fund Program for the delivery of various programs for physical activity participation and capability improvement was rolled out to State Chief Instructor Panel Members and Regional Directors of Coaching in August.

PCQ has available various funding opportunities for Zones to access. Regional Directors of Coaching have been consulting with Zone Chief Instructors and Zones in relation to available funding for Grass Roots, Coaching and Officiating programs and clinics.

As a result of funding and acquittal requirements, PCQ has streamlined the system by paying funding upfront on the completion of an agreements to utilise the funding appropriately within the acquittal period.

Funding is available for the 1July 2022 to 30June 2023 period and must be acquitted within the funding period. Contact your Regional Director of Coaching for any assistance.
