#### **Model Constitutions for Pony Club:**

As advised at the August Management Committee Meeting, PCQ has begun the process of developing a model constitution for pony clubs. PCQ has engaged legal professionals for consultation and guidance. PCQ is expecting this process to take several months and anticipate the final document will be completed in 2024.

#### **Active Participation:**

To encourage clubs to conduct activities and events in their local community and to get people moving and playing together, both riding and non-riding, PCQ will provide some minor funding in 2 ways:

#### 1. Community Fun Day - \$100 All Clubs

All Clubs were sent a notice advising that PCQ was wanting to give \$100 to each club that could be used for a Community Fun Day activity, end of year breakup or camp or a specific day involving your local community. Clubs were asked to provide their bank details and to return the form by Friday 27<sup>th</sup> October. The only qualifying criteria was that the clubs had submitted their 2023 Office Bearer Return and had paid their \$20 2023 affiliation fee.

To date (27<sup>th</sup> October), only 34 clubs have applied. A reminder has been sent to clubs to action the request to provide bank details.

#### 2. Moving Together - \$500 (\$50 x 1 Club per Region)

In addition to the \$100 giveaway, PCQ will also provide \$50 to one club per region (total \$500) for ideas on imaginative ways to encourage people moving together at your club e.g., parents verse kids "on" and "off" horses. A PCQ eNews has been circulated to all members asking for ideas as well as a notice also sent to clubs.

The closing date for both has now been extended to close of business **Friday 10<sup>th</sup> November**. These two minor funding opportunities are only available this year.

#### 2023 National Championships:

QLD was the only eastern state that made the trek across to Western Australia with 5 riders and 7 horses making the journey. Our team competed in Eventing - 2 riders/3 horses; Dressage - 3 riders and Showjumping - 1 rider with an additional rider attending the hub in Victoria. All riders performed extremely well with Lara Coombe the winner of the Eventing on Sting and placing 3<sup>rd</sup> on Trivago while Emily Geddes came in a commendable 4<sup>th</sup> place.

The QLD Tetrathlon side also attended in person, however were able to fly across to complete the swimming, running and shooting phases of the event. A report on their performance is in the Tetrathlon sub-committee minutes.

All QLD representatives are to be congratulated on their performances and commended for being outstanding ambassadors for their state, clubs, and zones. A massive thank you also to the parents for their participation and support in ensuring riders and horses travelled to Perth safely.

#### **Horse Registrations:**

There are a number of Pending registrations sitting in Credentials. Payment must be made by credit card (phone) or direct deposit before cards are issued. If these pending registrations are still there by the end of the year, they will all be cancelled.

#### 2023.11.15 General Business:

**JustGo Database:** The Office Manager advised the meeting that the database is currently in a blackout period for members to enable clubs to roll over for 2024.

New Membership Approvals - clubs should not be approving any applicant profiles until the applications have been approved at a meeting which will be recorded in the minutes. Clubs should only be approving new members as per their club constitution. The wording on the automated emails sent to applicants to be reviewed and amended.

Member Transfers and Renewals – PCQ to confirm with PCA on process and the MPIO to liaise with Office Manager on input. Once process is confirmed the office will advise clubs and zones.

The President also informed the meeting that the office had started developing a relationship with new PCA CEO.

**Meeting Attendance**: The President advised that after some considerable time and effort by a few parties that Zone 23 is once again functioning. Unfortunately, their internet is somewhat restrictive which impedes their reliable attendance at the state meetings. The President encouraged zones that are in a similar situation to consider appointing a representative to attend the state meetings on their behalf.

**Insurance – Open Days:** In response to this query, PCQ sought clarification from PCA who advise "that all participants at an open day event need have a Come and Try (CAT)/ Day Participation membership as a minimum. The CAT membership ensures that all participants (including non-PCA members) are covered for public liability insurance for the day at a PCA event. CAT membership does not include personal accident insurance". In simple terms this means if an open day participant is not a current pony club financial member, they must complete the day participation form and pay the relevant fee for each day the event is conducted. This will be circulated to clubs.

**State Sporting Event:** The meeting was advised, that all delegates and teams managers conducted a briefing session to discuss the future of their discipline, summary yet to be distributed and could be fed into the proposed session at Southport PC in January. It was also suggested this could also occur at other state events.

**2023 Nationals:** VP Tracey Camilleri advised that while the trip across was brilliant, the horses travelled well and it was worthwhile going, didn't however believe the riders experienced the full feel and hype of a national's event and there were some issues that need addressing. The event was held at the State Equestrian Centre with the cross country being conducted about 50km away. The WA CEO had resigned which left the office staff to organise the event. The Dressage was run as a hub and QLD had to video its own riders with no equipment provided. QLD had three dressage riders who had personal bests with the first test held in the indoor area which was slightly disconcerting for the riders. It is disappointing that the dressage results are still yet to be announced. Not impressed with the hub with no feedback after each test. All three showjumping events were held in the indoor with the first two courses quite tight, not flowy. All the horses stood up very well to the competition and the riders behaved every well. A meet and greet was held on the first night with no introduction of the riders and the presentation was very disorganised. Overall, the states need to continue competing at the National Championships but hubs are not a great thing.

The SCI congratulated the riders and parents and welcomed all feedback from those who attended.

The President advised PCQ would provide relevant feedback to PCA.




