Thereafter all cups to be FEI approved showjump cups and breakaway safety cups max depth 20mm. (Approved Plastic Cups). The rules to be amended to be effective by 1st January 2026.

- **Jumping Equitation & Showjumping** Business Arising 5.6 Metal Cups: request for funding of equipment upgrade for clubs \$ to \$ basis the Executive did not approve this request however would fully support clubs wishing to apply for funding through the various grants available for the purchase of this equipment.

The Executive reviewed these reports which were approved with the exception of the above as outlined.

Strategic Plan 2023-2025:

The strategic plan comprises of 4 pillars being Governance & Culture; Participation, Development & Resources; Communication & Marketing; Integrity & Ethics. Most strategies are in progress with several being completed. An APP for horse declaration has been developed and trialled at Southport and from reports works well. The use of the APP is not compulsory and will be set up for each individual club on request. The APP allows an individual to login via a QR code or JotForm, complete and submit, copy of which goes to the recipient club; by using this APP privacy of member's details remains inhouse with PCQ.

The strategic plan can be accessed via the PCQ website at Resources>Insurance & Policies.

Volunteers' Register:

This is a reminder that clubs and zones should have a Volunteer/Workers Register in place at each activity outlining the name of the volunteer/worker, the assigned job etc. This document is important in the event of an incident occurring which may result in an insurance claim. A template will be forwarded to all clubs for use should a club not have this register in place.

Model Constitution for Pony Clubs:

As advised previously this is currently being developed and work is ongoing.

Scheduled Meeting Dates:

The dates for the remainder of the year are 21 March, 23 May, 25 July, 5 September (also AGM) and 7 November.

Please note when scheduling these dates, holidays, Executive meetings, key personnel availability, National Committee meetings, PCQ sub-committee meetings and report deadlines were considered.

Agendas will be forwarded no later than the Tuesday preceding the scheduled meeting. If a delegate is unable to attend the meeting, please ensure an apology is sent through to enable it to be recorded in the minutes.

Hot Weather:

Due to the heat wave conditions we have recently experienced, this is a timely reminder to zones & clubs to ensure they are aware of and abide by the PCA Hot Weather and Horse Welfare Policies

Game Plan:

This is a free resource that is available through the Australian Sports Commission to clubs and now the state authority and is designed to measure, develop and improve the capability of all levels of sport. Game Plan replaced the previous Health Check portal. Only a handful of pony clubs have accessed this resource.

Food Safety Supervisors Legislation Standard 3.2.2A:

This legislation covers non-profit organisations that sell meals on at least 12 days each financial year and are required to hold a food business licence with their local council. A meal is defined as food that is, or is intended to be eaten by a person sitting at a table, with cutlery and is of adequate substance as to be ordinarily accepted as a menu. PCQ investigated whether this applied to pony clubs and advise clubs do not meet the specific requirements (if in doubt consult your local council). Whilst not compulsory, clubs should consider having at least one person undertake the free online course.

- Clubs have the option of setting a restriction on renewing members. This will prevent payment until the club has approved the member/s through a meeting. All new members require approval and can be found in Summary by Membership > Summary by Club Member Status
- Transfers also require approval and can be found under Club Members > Membership > Transfer Requests
- Please do not join as a Centre Member only, if you do you are not a current member of PCQ and will need to go to PCA to have the membership deleted and monies refunded before you can join a pony club this year.

2024 Waiver Forms:

Individual Member Agreement will be a compulsory field when joining or renewing membership on JustGo.

PCA will load the member waiver on Just Go and the member will also be required to acknowledge compliance with the PCA National Integrity Framework as a mandatory requirement for joining or renewal.

Day Participant Event Waiver and Liability Declaration is on the PCQ website – Resources – Forms – Clubs and has replaced the Open Day Liability Dec and Open Day Waiver.

To be filled out and signed by any non-financial PCQ rider and Come and Try Day Participants <u>https://ponyclubqld.com.au/wp-content/uploads/2022/12/Day-Participant-Event-Waiver-and-Liability-Declaration-Pony-Club-Australia.pdf</u>

Come & Try can also be made Active in a club Membership Setup and entitles the participant to be covered under the Pony Club's Equine Liability Insurance Policy only. The PCA fee is \$11, the PCQ fee is \$9 making the total 'Display Alternative Price' \$20; a club fee may also be added if desired.

Individual Member Event Waiver and Liability Declaration will be a compulsory field on any online nominations set up through JustGo.

If using Nominate or any other event software for online nominations, the Waiver will need to be incorporated in the setup as a compulsory field.

For any other competitions e.g., Gymkhana, Campdraft etc. the Waiver must be handed in with the Horse Health Dec prior to the commencement of the competition.

Clubs/Zones will be advised to note this on their programs and keep a supply on hand on the day of competition.

Paying the \$20 Affiliation Fee on JustGo:

Go to My Club – Affiliation – and follow the prompts.

Office Bearers Returns:

It is more important than ever for Zones and Clubs to return the 2024 Office Bearers Return following their Annual General Meetings. Without searching through each Zone or Club on JustGo database, clicking on Club Members – Summary by Membership – Member Role and opening the different categories individually e.g., Secretary, President etc we have no idea who the current Office Bearers are for 2024.

Horse Registrations:

There are two (2) options available for Horse registrations.

Option 1: JustGo database through the rider's profile. The steps are:

- Click on Credentials
- Add new select horse registration from drop down options
- Ensure the "Official" box is ticked if performance cards are required
- As there is no payment option attached to horse registrations, payment to be made by either calling the office with credit card details or a direct deposit into the PCQ bank account.

Option 2: Complete the Horse Registration Application Form which is located on the PCQ website at:

• Resources > Forms > General. Payment options are on this form.

Clubs and Zones running Official Events in February:

May allow riders to compete competitively without producing their performance cards, providing they can prove they have applied for the card. There is a huge backlog which is being addressed as quickly as possible, Australia Post is very slow and it doesn't help when members leave it a few days out from a competition to ask for a horse to be registered.

Official Programs and Gymkhana/Sporting/Campdraft or Open Day Programs:

All Official programs must be sent in to PCQ for approval, once the program has been approved it will be posted on the PCQ website and can be circulated. Prior to the competition a list of all Officials/Judges must also be forwarded to PCQ for approval.

Any other program must be approved by the Zone Chief Instructor prior to circulation

Open Days:

Clubs need to ensure Open Day Advice Form for Competitions, Clinics etc has been signed by the Zone Secretary prior to forwarding to PCQ.

Club Uniform Details:

If changing or adding to club uniform you must get approval from your zone before submitting the form below to PCQ.

2024.02.15 General Business:

PCA Safety Meeting – VP Geoff Thomson advised he attended a meeting of the committee recently where event medical variations and incidents reports were discussed. Reporting has increased with a 4.6% increase of QLD incidents being reported and overall reporting of safety issues on the grounds. He does not believe that clubs are reporting all incidents and will in due course ask PCA to refine the reporting requirements. Geoff further reiterated if a zone or club is unable to comply with the first aid requirements, he needs to be made aware. A comment from the meeting that there is a lot repetition on the incident reports which seems superfluous.

Extreme Weather – The President acknowledged the extreme weather which has affected the state over the past few months. It was noted in the south-east of the state that Albany Creek, Burpengary, Samford, Mudgeeraba, Cedar Creek, Tamborine & possibly Redcliffe and other clubs were affected in various ways.



The central, north and far north regions of the state has been extremely hot resulting in no activities being conducted.

In the Cairns area, it was reported that a young pony clubber was instrumental in saving several horses from floodwaters.

Racing Qld – The President advised the delegates, that PCQ were meeting with Racing Qld shortly to discuss building a relationship and sponsorship opportunities.

PCQ Website – the President informed the meeting that a new modernised PCQ website is currently being developed by John Martin who is experienced in IT & works with young people. John is working closely with the SCI and the Office Manager on this project and when completed a special launch of the new website will be undertaken. The President thanked John for his dedication and commitment to PCQ.

Administration Q&A sessions – The office staff have agreed to conduct short 1-hour sessions on a trial basis to assist clubs and zones with general administration queries.

The meeting welcomed this initiative and agreed the benefits would be productive. Suggestions from the floor included submitting questions prior to the session and pre-determined subject matter.

VP Tracey Camilleri advised there is a Facebook group called PCQ Secretaries that secretaries can join. The President asked as this is not administered by PCQ who is the administrator.

- 5.5 State Champs 2024:

Applications to host 2024 Events. Showjumping & Jumping Equitation: Zone 7 Approved for SJ/JE – Wednesday 3rd - Saturday, 6th April.

DR/CT/ODE No nominations as yet. Delegates asked to follow up with their Zones, keeping in mind that the events can be separated and run by different zones, e.g. Dressage only, OR Dressage & CT, OR Horse Trials only, OR Horse Trials & CT. A couple of zones indicated they might consider HT & CT.

5.6 Metal Cups (fixed) for SJ to be banned 1.1.2024 – Photo supplied. As well, to note, in the Show Jump Rule Book, General Rules Q states '*FEI approved Show Jump cups and breakaway Safety Cups ...no longer acceptable by 01.01.2025.*'

The meeting agreed to extend this date to 01/01/2026 to allow Clubs time to upgrade. This means that all Metal Show Jump Cups to be phased out by the end of 2025 Rule to be amended to be effective by 1.1.2026.

NO UPDATE ON: Sub Committee to request funding from EOB for Equipment Upgrades for Clubs on a \$ for \$ basis. Maximum support proposed at \$2000 per Club.

Also noted that there are lots of Grant Options available to assist in this process as it is a 'Safety Aspect'

5.9 Medical Standards: ARE THE CLUBS IN YOUR ZONE ABIDING BY THE CURRENT MEDICAL REQUIREMENTS?

Geoff Thomson requests clubs to let him know if the requirements are too erroneous as soon as possible.

Meanwhile a couple of things to note: The standard of cover required has CHANGED from the number of riders to the number of rings and the number of ACTIVE riders at any one time, e.g if you have 3 rings you probably have 6-8 active riders. There is a variation acceptable where one (1) person covers two (2) rings because of the position of the rings and the first aid, e.g. between two rings.

Advised 'desired changes' to Medical Requirements for presentation to PCA meeting. Clubs are generally charging a levy on top of nominations to cover the First Aid requirements.

5.10 Gear Check Stewards. Knowledge of current PCA Gear Check Book. Can do online. Zone 1 currently doing preparation by Zoom and running clinics

6. Correspondence:

- NSW CT & Horse Trials Championships on 18 & 19 November. Congratulations to the team who performed well in both competitions and as ambassadors for pony club. Results attached.
- All clubs have been advised that the 2024 Calendar is on the website.

7. Items for General Business:

7.1 Use of Nominate for interstate events. Discussion on how best to establish the Queensland riders nominating for interstate events. PCQ is required to approve the nominations, also needs to select a Team Manager, provide uniforms etc. Melinda Hughes to speak with PCQ Office and Nominate to implement this request.

7.2 Clarification to be obtained by PCA GEAR COMMITTEE:

- 1. Compression Hoods & Bonnets: they are not the same, they cannot be used together, and where they are allowed e.g. warmup/competition.
- 2. Stirrups hanging 'freely': rule to state this means 'on the outside of the saddle' or 'breakaway stirrups must be used'.

Note when PCQ receives clarification on these points they will be advised to clubs via e-News.

7.3 OPEN DAYS: Notice to clubs or zone running Open Days:

- As per application form these days MUST BE RUN UNDER PCQ & PCA RULES. This is to be amended with more specific details. Basically, Open Days are run as follows:
 - Open Days can be Open Competition Days or Open Training Days
 - Competition days must have a Gear Check inspection; Showjumping a C/B and Judge from PCQ list. See Rule Book for specific requirements if your day is to be used as a qualifying event for State Championships.
 - Training Days must have a PCQ/EA Course Builder if being run as training for a competition, i.e. over a course; and a PCQ/EA Coach with jumping in the level of their certificate.
