#### **Queries from the Executive Report:**

#### Game Plan:

Firstly, PCQ acknowledges that while this will create more work for volunteers it will greatly assist with building capacity within zones and clubs making the sport more viable and sustainable. The Game Plan has been in place for several years and replaced the former resource known as 'Health Check'.

As PCA has registered with the Game Plan, PCQ and subsequently zones and clubs are now also required to register a profile and complete the modules.

PCQ will provide a step-by-step guide on how to register with the preference to commence with Zones, followed by the clubs, however clubs are welcome to register to anytime should they wish to do so.

#### PCQ SteerCo26:

Under the PCQ Strategic Plan Pillar 1.6 Capability Improvement Initiatives, and in compliance with our funding PCQ has developed a next generation succession model known as the PCQ SteerCo'26.

PCQ is seeking input from younger members across the state with a diversity of skills and not necessarily members in current leadership positions.

#### Database:

Login to club Membership Setup, set up for 2024, check age descriptions, fees and make Active. Club fee is added in at 2. Membership Pricing > Display Price Settings > Display Alternative Price add Club, PCA & PCQ fees together > Display Price.

#### Following Club AGM:

Send in to PCQ – 2024 Club Office Bearers & Risk Management Return, AGM Minutes & Financials, PIC number to be filled in.

Update Club Role on JustGo database > member profile > Club Role > Update Roles & tick appropriate box e.g. President, Treasurer, Secretary, Cl, Coaches, Club Admin. Go to members who no longer have a role and untick.

#### Transfers:

For those who have already purchased membership for the current year and transfer to another club:

- Secretary of incoming club accepts the transfer > rider goes into profile on JustGo database > Go To
  Membership > click on the Club they have transferred to > click on the Membership category they have
  joined under > Payment. The PCA & PCQ fees will come up as minus but they will then pay the new
  club fee.
- When this process has been completed the member will show up as being a current financial member of new club. If this process is not completed the member may sit in new club membership as a member of old club.

#### Fair Play Vouchers:

The Fair Play Vouchers cannot be redeemed through the JustGo system as the system does not have the functionality to validate and check the vouchers.

There are two options available:

- 1. Pay the full membership amount; provide the vouchers to the club; they can claim the monies from the government and then can refund you the voucher amount outside the system.
- 2. Give the voucher to the club, once the club has redeemed the voucher monies, they can pay for the membership using their club card.

#### **Horse Registration:**

Cards are available for Dressage, Combined Training, Horse Trials (ODE), Jumping Equitation, Showjumping.

 Register the horse on the JustGo database through Rider Profile > Credentials > Add credential Must tick Official Box if cards are required. The registration will be approved and cards posted out

following payment. Payment can be made via Credit Card or Direct Deposit; payment cannot be made through the database.

- Ring the PCQ Office for adding, replacing cards or changing details, this cannot be done on the database.

#### Come & Try:

At club musters - only once

Form must be completed and fee of \$20 paid prior to participation. Club to keep a copy and a copy with payment to be sent to PCQ Office. Form found on PCQ website > Resources > Forms – Clubs

#### **Open Days:**

Competitions, Clinics & Camps open to non-pony club members. Open Day Competition Advice Form to be lodged with PCQ Office 30 days prior to the event. It must be signed by the Zone Secretary or it will not be accepted. Ts & Cs are listed on the form which can be found on the Forms page of the website under Clubs. The fee for non-pony club participants is \$20, secretary to return the completed Registered Day Participant Remittance Form, with payment, to PCQ Office within 14 days of the event.

#### **Proficiency Certificates:**

Process for D & D\* - assessed by Club Chief Instructor, results forwarded to PCQ Office on Attendance-Results-Report Interactive form found on the PCQ website > Resources \_ Forms > Clubs Process for C - Written test to be done through PCA Academy with Assessor email recorded as admin@ponyclubgld.com.au

- 1. The completed test will be forwarded to PCQ Office > an Invoice for \$15 marking fee will be forwarded to parent.
- 2. Upon receipt of payment the test will be sent to the Assessor
- 3. Marked test will be forwarded to Zone CI, Club CI and Candidate
- 4. Zone CI will arrange for candidate to be assessed for practical test.
- 5. CI will send Attendance-Results-Report into PCQ Office for results to be uploaded to candidate's credentials.

This process also applies to C\*

#### Official Day Competitions:

Programs must be sent into the PCQ Office for approval before being advertised. If alterations are required the Zone/Club will be notified, updated programs to be resent and once approved will be posted on the PCQ website.

Officials for the day must also be sent into the PCQ Office for approval.

Results from Official Day Programs to be forwarded, as attachments to PCQ Office, in a timely manner.

Programs for Sporting, Campdraft, Horse Sports, Team Penning etc. must be approved by the Zone C.I.

#### **Complaints Process:**

Clubs should endeavor to rectify problems/complaints at a committee level, if this is unsatisfactory seek assistance form the zone. If all else fails PCQ has a Membership Protection Information Officer to provide information on how to resolve problems; contact details can be found on the PCQ website > About > Contact Us

#### **Blue Cards:**

It is a legal requirement for Coaches, Officials and Office Bearers working with children to have a Blue Card




