### **AGE GROUPS**

10 & UNDER - 11-16 YEARS - 17-25 YEARS, SENIORS

NOMINATIONS: \$5 – RE-RUNS \$2 (1 re-run permitted) Fastest time in each Age Group NOTE: TO BE ELIGIBLE TO RECEIVE PRIZES,

1 HORSE, 1 RIDER COMBINATION MUST COMPETE IN THE ENTIRE PROGRAM.

#### Conditions of Entry -

- 1. Judges' decision is final
- 2. All NON pony club riders MUST complete the relevantPCA Day Participant Event W#aiver and Liability Declaration form with their nomination and ride/compete at their OWN RISK.
- 3. This event is run under PCQ Sporting & Formal Gymkhana Rule Book 2024. Any protests MUST BE IN WRITING within 30 minutes of any incident, accompanied by a \$50 fee which is refundable if the protest is upheld. Only the owner, his authorised agent or the rider of the horse taking part in the competition is entitled to lodge a protest. A disputes committee will be responsible for any decisions regarding a dispute.
- 4. To be eligible to enter the FEATURE EVENT a 1 horse 1 rider combination MUST compete in all day events
- 5. Excessive use of the whip, abusive language or bad behaviour or other cruelty WILL NOT be tolerated and will mean disqualification for the entire program. Any person disqualified will forfeit their nomination fee/prizes.
- 6. A rider may ride more than 1 horse. Separate nominations are required for each horse. One (1) horse MAY NOT be ridden by more than 1 rider. No stallions, colts, entire or rigs are eligible to take part in any event, competition or otherwise as under PCQ rules
- 7. Safety helmet AS/NZS 3838 Marked SA1 Global, AS/NZS ARB HS 2012 (racing helmet) Marked SA1 Global, American Standard ASTM F1163, PAS 015 (1998 or 2011), VG1, 040 (2014-12) EUROPE only. It is mandatory to wear close fitting equestrian boots (English/Jodhpur, long/top/field boots) with firm sides, full smooth soles; square cut heel at least 14 mm high. Correctly fitted short lace up type riding boots under correctly fitted gaiters are permitted. 'Cowboy' boots can be worn but only with jeans or stockman-cut trousers. Pants must cover the cop of the boots; no tucking pants into boots. Golf style lace up, horseshoe or similar brands are NOT ALLOWED. UNDER NO CIRCUMSTANCES WILL COLLARLESS/SLEEVELESS SHIRTS/TOPS BE ACCEPTABLE. ALL CORRECT SADDLERY AND DRESS IS ENTIRELY THE COMPETITORS RESPONSIBILITY. All participants must comply with equipment and dress rules of Pony Club. Please check Pony Club Australia National Gear Rules 2024 on acceptable Saddlery, etc.
- 8. In all events only fastest run per horse counts. Refunds will not be given after the horse has competed in the first event of the program unless the competition is called off due to unforeseen circumstances
- 9. The use of wireless telecommunications by parents, guardians, spectators, and riders will not be permitted in any way as it is 'DEEMED AS OUTSIDE ASSISTANCE". Use of such telecommunications will incur disqualification for the competition
- 10. Mobile phones are NOT to be carried by any rider whilst on horseback or they will incur disqualification from the competition

#### **RESERVATION OF RIGHTS:**

The Organisers reserve the right:

- 1. To cancel any class or event
- 2. To divide any Class or to combine classes lif less than 3 competitors pursuant to the Rules.
- 3. To alter the advertised time
- 4. To refuse entry with or without stating the reason
- 5. To transfer Competitors between sections of a class

If a horse/rider is scratched due to illness/injury a refund will NOT be forthcoming unless:

- 1. The Organisation Committee is notified BEFORE the start time of the event
- 2. A doctors certificate/vet certificate or chief instructors' letter is received within 7 days of the event
- 3. A 10% administration fee will be deducted from the entry nomination fee

#### **BIO-SECURITY**

- All participants attending the grounds/facilities MUST complete the Horse & Participant Health Declaration Form which can be downloaded from the PCQ website. There will be no entry to any competitors without a completed form. The Club COVID 19 Plan is available at the secretary's office.
- Be aware of COVID 19 basic guidelines
  - Only attend if you are well. Those persons with a temperature over 37.5 degrees should not attend
  - Only touch your own horse, equipment etc and maintain social distancing of 1.5m at all times
  - Practice good hygiene/personal hand sanitising/20 second handwash

#### **BIO-SECURITY POLICY**

Our event bio-security plan is a set of preventative measures and actions aimed at reducing the risk of infectious diseases and pests on and off the venue and between persons and horses at the venue. All horses' owners and competitors should be aware that there is a bio-security obligation to take all reasonable steps to ensure your activities do not spread a pest, disease, or contaminant. Competitors are to ensure good bio-security practices at home and at the event and to follow the instructions of the organising committee or risk expulsion from the event. Horse and Participant Health Declaration forms are a mandatory requirement for all events. Other biosecurity and workplace health and safety measures that aim to provide the safest environment for horses, competitors, volunteers and visitors include-

- . No horses with signs of illness are to be brought onto the grounds
- . No communal horse water troughs are available at this event
- . Do not share equipment, including food and water containers between horses
- . Competitors are responsible for cleaning up manure from yards and placing it in the designated area. Please bring your own rake/shovel
- . Competitors are required to advise the event organisers immediately if a horse is sick. Stop all essential contact with the sick horse. Do not allow children to have close contact with the sick horse. In the event of horse movement restrictions, participants are responsible for the care, maintenance and costs of their own horses and themselves, including but not limited to feeding, bedding, veterinary costs and their own personal needs. Everyone handling horses should wash or sanitise hands between contacting different horses

If a horse is confirmed to have an infectious disease the owner/lessee will be responsible for all veterinary costs and if the venue is locked down and quarantined will be responsible for all costs associated with this. In the unlikely event of a bio-security incident the Organising Committee will implement an event bio-security plan. All persons concerned will be notified regarding the incident and expected to follow the directions given by the Organising Committee. Everyone will be expected to remain at the venue until cleared to leave by the Organising Committee.
