Extract from 2026 Horse Trials' Rule book, sections 8 and 11.

#### 8. GRADING OF HORSES

d. Once a horse has one (1) qualifying result or Minimum Eligibility Requirement at an EA level, they are termed qualified at that level in Pony Club. A qualifying result/MER as specified in 11(b). Refer to 11(a) for procedure to upgrade. Please note, EA requires MERs to compete at 1\* and 2\*.

#### 11. UPGRADING

(a) Should you wish your horse to be upgraded horse and rider combination must have 3 qualifying results (Minimum Eligibility Requirements – MER) before you can choose to go up a level. Horses can compete up to the highest grade shown on the card. It is the responsibility of the rider to inform PCQ of any EA qualifying result.

To upgrade your horse's competition level, an "Application for Horse Trials' Upgrade' form needs to be completed and emailed to PCQ with copies of the relevant MERS Performance card will be upgraded by the PCQ TD at the next Official competition.

## (b) Minimum Eligibility Requirements

A Minimum Eligibility Requirement (MER) is achieved by completing a Competition within minimum parameters of all round performance as follows:

- (a) Dressage Test: not more than 45 penalty points (or 55%)
- (b) Cross Country Test:
  - A clear round at cross country obstacles
  - Not more than 75 seconds exceeding the optimum time in the Cross Country Test (30 penalties)
- (c) Jumping Test: not more than 16 penalties at obstacles.

(All MERs obtained in the previous 2 years will be counted according to the rules in place at that time)

<u>For a horse and rider to progress from Introductory to Preliminary</u>, they must have 3 qualifying results (MERs) in their current official class.

<u>For a horse and rider to progress from Preliminary to One Star</u>, they must have 3 qualifying results (MERs) in their current official class, except one of these results may not have more than 20 Cross Country jumping faults.

<u>For a horse and rider to progress from One Star to 2\*</u>, they must have 5 qualifying results (MERs) in their current official class, except one of these results may not have more than 20 Cross Country jumping faults. All other requirements re dressage score, XC time faults and showjumping penalties as above.
